COLLEGE CREDIT

Through reciprocal agreements, Landmark students can gain access to college credit for their course experiences through select regionally-accredited institutions:

- Western Carolina University (SACS)
- Western State Colorado University (NCACS)
- University of Utah (NWCCU)

Certain limitations apply per school. Students are responsible for determining the eligibility of their particular course type, requirements for credit transfer to their own school, and pay credit fees to the school providing the credit.

Students must fulfill the credit request processes before their course starts. Most college credit requests will not be fulfilled after the course completes.

Additionally, students are advised to work with their own advisor or department head to determine if reciprocal credit is available through their own institution.

COURSE TUITION AND PAYMENT POLICY

Cancellations & Refunds Policy:

- Your 25% course deposit is non-refundable and non-transferable upon payment, and is required to reserve a space in the course. If you have a coupon code it can be added at checkout. Students paying by alternate funding options (employer, Americorps, financial aid, etc) will be reimbursed the course deposit upon full payment by the funding source.
- Your remaining balance is due 30 days prior to the course start date.
- If a course cancels due to low enrollment, all funds paid are 100% refundable. Contact the office if you would like to transfer to a future course.
- If student cancels before the course start date, funds paid minus the course deposit are refundable or transferable. After the course starts, there are no refunds or transfers.
- Exception: Students using Americorps Funds will not receive any refunds as per enrollment requirements at Western State Colorado University.

ATTENDANCE POLICY

Attendance:

Students are required to attend all class sessions and field exercises. Students may request no more than 10% of the course hours of excused absence. Review of missed curriculum or examinations is the student's responsibility. Absences, either unexcused or exceeding 10% of the course hours excused, are grounds for dismissal from the course with no refunds of tuition or course costs.

Tardy is defined as <30 minutes at a time;
Absence is defined as a block of time missed with prior instructor approval (sickness, prior approved appointment, etc.)

Course Completion:

Students must successfully complete and demonstrate proficiency in the following areas:

Didactic:

- Minimum requirement for successful course completion is full participation in the course.
- If a written examination is administered, students must score 80% or higher to be eligible for certification in all but NOLS courses.
- NOLS courses require a score of 70% or higher to qualify for certification.

Skills:

- Skills will be demonstrated and practiced during practical skills sessions and scenarios throughout the course. In a practical examination, students must demonstrate proficiency at the level of their training to be eligible for certification.

Self Withdrawal:

Any student choosing to withdraw from the course before course completion accepts that no refunds of tuition will be awarded.

STUDENT RECORD RETENTION AND ACCESS POLICY

Landmark Learning students can have access to financial records, grading records, attendance and tardy records as well as complete transcripts by request without expense to the student. Requests can come as a phone request, in-person request or an email or regular mail request to the Student Services Coordinator. Electronic student records are maintained

indefinitely. Paper records are kept for seven years. Replacement certification cards managed by the Landmark Learning office are available for \$5.00 per card along with a self addressed envelope with request by mail.

MONITORING STUDENTS AND GRADING STUDENTS

At each course start, information on student evaluation criteria, during and at course end, are outlined and highlighted orally by course instructors. In addition, appropriate conduct is addressed. This information is made available to students pre-course in the course expectations. Students are given a written document "On Course Information Form" that highlights this information at the start of each course. Students must complete and sign this document before the course start.

Instructional staff must be available at the appropriate instructor to student ratio during practical exercises. Individual and group comments are balanced throughout the course. Students are encouraged to ask for assistance and feedback. Instructors are available during lunch breaks, during class breaks and before and after class each day for individual student contact.

Students who are identified as performing poorly or below standard are addressed in private directly to share concern and assess the student for needed support. As needed, action plans and follow up are created with one or both of the course instructors. Students who need additional support are identified early in coursework in order for support to be meaningful.

Course Failure:

If there is course failure, the student must contact the LL office to discuss remediation and to schedule a retest. Remediation and retest policies shall be those of the training affiliate of this course.

A letter grade will be issued by the office, based upon the results of both written and practical assessments. Demonstration of skills competence throughout the course and successful completion of any practical skills exam could raise or lower the grade up to 5 points. Pass/Fail is used for courses with no written examination.

Questions about grading can be directed to the Student Services Coordinator.

Written Exam:

LNT Master Educator, Epinephrine Administration, NOLS Wilderness First Aid, NOLS Wilderness Medicine for the Professional Practitioner and ACA skills courses require full student participation for completion. These courses do not have course exams.

All other Landmark Learning courses (EMT Intensive, EMT Refresher, ACA Instructor, Wilderness StarGuard, Wilderness StarGuard Instructor, ASHI, and NOLS) are graded with the following criteria for written exams:

92-90 A-
89-87 B+
86-83 B
82-80 B-
79-77 C+
76-73 C
72-70 C-

Practical Exams:

Students have the opportunity to pass each practical exam with two attempts. Practical exams are pass/fail.

A grade will be issued based upon the results of both written and practical assessments. Demonstration of skills competence throughout the course and successful completion of the practical skills exam could raise or lower the grade up to 5 points.

Failing Grades:

A student who fails one component of final testing (written OR practical) will be issued a D. No certification will be issued. A student who fails both components of final testing (written AND practical) will be issued an F. No certification will be issued. A student who does not complete the course will be issued an Incomplete (I).

Questions about grading can be directed to the Landmark Learning office.

STUDENT GRIEVANCE POLICY

It is a mutual goal of Landmark Learning and its Affiliates to ensure that educational coursework of quality is provided. When problems are identified by students, Landmark Learning will make every attempt to find a fair and reasonable solution through our internal complaint procedure. In the event that the student is not able to resolve their complaint(s) directly with available Landmark Learning Instructional Staff, the student has the right and is encouraged to take the following steps:

1) Complaints should be submitted in writing and mailed to the Landmark Learning office. Complaints received by phone will be documented, but the complainant will be requested to submit the complaint in writing.

2) The letter of complaint must contain the following information:

- Title, location, and dates of coursework;
Names of Instructional Staff;

- A detailed description of the alleged problem(s);
- The approximate date(s) the problem(s) occurred;
- The names and titles/positions of all individual(s) involved in the problem(s), including administrators, instructional staff and other students;
- List what was previously done to resolve the complaint.
- The name, email address, telephone number and mailing address of the complainant. If the complainant specifically requests anonymity be maintained, Landmark Learning will not reveal his or her name during the internal investigation;
- The status of the complainant with Landmark Learning (current/ former student, etc.);
- In addition to the complaint, copies of any relevant supporting documentation should be sent with the complaint (enrollment agreement, course schedule, previous communication between Landmark Learning and the student, etc.).

CPR AND AED ASHI 101

Contact Hours: 4 Hours

Description: ASHI CPR and AED is a combined CPR and AED program designed specifically for laypeople. The program is an excellent choice for both the community and workplace setting, and is based upon the 2010 International Consensus on Cardiopulmonary Resuscitation (CPR) and Emergency Cardiovascular Care (ECC) Science with Treatment Recommendations (CoSTR) and other evidence-based treatment recommendations.

Eligibility: None

Target Population: This course is for anyone with limited or no medical training who seeks a course in CPR and AED use to meet job, regulatory or other requirements.

Materials Provided: Digital copy of ASHI CPR and AED Student Handbook provided at end of course

Testing: Written and practical exams at course end

Outcomes: 2-year ASHI certification in CPR from Landmark Learning

BASIC FIRST AID ASHI 102

Contact Hours: 4 Hours

Description: ASHI Basic First Aid was created to help students develop basic first aid knowledge, skills, and the confidence to respond. The program is an excellent choice for both the community and workplace setting, and is consistent with recommendations of the 2010 National First Aid Science Advisory Board and OSHA's best practices for first aid training programs in the workplace.

Contact Hours: 16 Hours

Description: Designed for people interested in medical care where modern prehospital care and supplies are absent, this training is the best for individuals who want to develop knowledge and skills caring for patients in times of community disaster or for mission and medical teams traveling abroad.

Eligibility: Must be at least 16 years old.

Target Population: Relief workers, organized first responder teams, local and regional public safety officers, mission teams and humanitarian groups traveling overseas.

Materials Provided: Padgett, J. (2011). Basic relief medic training manual. Cullowhee, NC.

Testing: Students must complete written exam with an 80% or higher pass rate.

Outcomes: Certificate of Completion from Landmark Learning will be awarded upon successful completion of written exam

Description: Provides participants with a comprehensive summary of Leave No Trace skills and ethics through practical application in a field-based setting; combination of 1-day classroom component, 3-day or 2-night field component, and 1-day community outreach opportunity; practice Leave No Trace teaching strategies by delivering a planned lesson; prepares students to deliver 2-day Leave No Trace Trainer courses and 1-day or shorter Awareness Workshops

Eligibility: None

Description: Builds on background in urban emergency care; learn how to improvise equipment, deal with challenging environmental conditions, and make difficult medical decisions in remote location; intense, hands-on curriculum uses daily role plays, case studies and practical scenarios

Eligibility: Current EMT, Paramedic, RN, PA, MD, DO, PT

Target Population: EMTs, nurses, physicians, and other medical professionals

WILDERNESS EMT 3+1

This intensive course combines wilderness medicine with urban medical care practices into a single month-long program that includes clinical rotations helping to provide care for real patients. After four weeks of classroom education, practical skills, scenarios and full-scale mock rescues, you will be ready to handle medical emergencies, in the wilderness or right in town.

The first three weeks of the experience is focused on 190 hours EMT training, with an immersion into urban care. You will complete 12 hours of clinical time on an ambulance and/or in an emergency room setting, and be eligible for both the North Carolina Office of EMS exam and the National Registry of EMTs exam at course end. At the end of the EMT experience, the course continues with the 5-day NOLS Wilderness Upgrade for Medical Professionals to receive your WEMT certification. This 48-hour training focuses on prevention and treatment of common injuries and illnesses in remote and outdoor settings with limited resources.

WILDERNESS LIFE GUARD (WLG) **SAI 101**

Contact Hours: 16 Hours

Description: Course designed to satisfy needs of wilderness trip leaders with a focus on prevention in backcountry swimming environments; typically offered as standalone course, but may be taken as an add-on to other standard lifeguarding courses

Eligibility: Minimum 16 years old; current certification in WFA and Adult CPR as minimums (WFR preferred), Swim 100 yards, Retrieve a submerged weighted object, Tread water for three minutes without using hands

Target Population: Backcountry guides, canoe trip leaders, private expedition groups, college or university outdoor education programs, hiking club trip leaders, wilderness therapeutic programs, and adventure race safety personnel

LANDMARK OUTDOOR EDUCATOR SEMESTER

The Landmark Outdoor Educator Semester (LOES) is a combined course experience taught May-June each year for rising professionals in the outdoor education and recreation fields. This combination of nationally recognized certification trainings offers students an opportunity to make themselves marketable in the outdoor community, building a resume founded in national standards. Training does not substitute for experience, however training helps folks gain the work that furthers their outdoor professional career. The LOES is available for up to 12 hours of college credit (\$55/credit hour) through Western Carolina University.

Contact Hours: 380+ Hours

Description: Rising professionals in the outdoor recreation industry, college students in their gap year, individuals at a career-choice crossroad, military personnel transitioning to civilian working life and desiring a career recreation pursuit.

Prerequisites:

- Proof of age 18 years or older
- Education: HS Diploma or equivalent
- No felony convictions and a clean driving record
- Minimum of 3 weeks backcountry living experience
- Able to swim 100 meters
- Able to hike and carry personal equipment 2 miles
- Previous tandem canoe experience
- Previous teaching experience preferred
- Letter of recommendation from current Academic Advisor or Department Head

Certifications Received: Certifications, certificates of completion, and testing eligibility shall be awarded for each Semester segment, see each course page for specifics.

Continuing Education: The Landmark Outdoor Educator Semester is eligible for your choice of up to 15 hours of college credit from Western Carolina University, right here in Cullowhee, NC. SACS-accredited university, WCU will be able to offer transfer of your credits to your current or future school.





Students should expect to apply at WCU, pay a \$65 one-time application fee, and enroll for the credits at least four (4) days before the course start date. The course is offered \$55 per credit hour.

Landmark Learning will provide final grades to WCU within 5 days of the Semester completion, and transfer will be available to students after that according to WCU's calendar schedule.

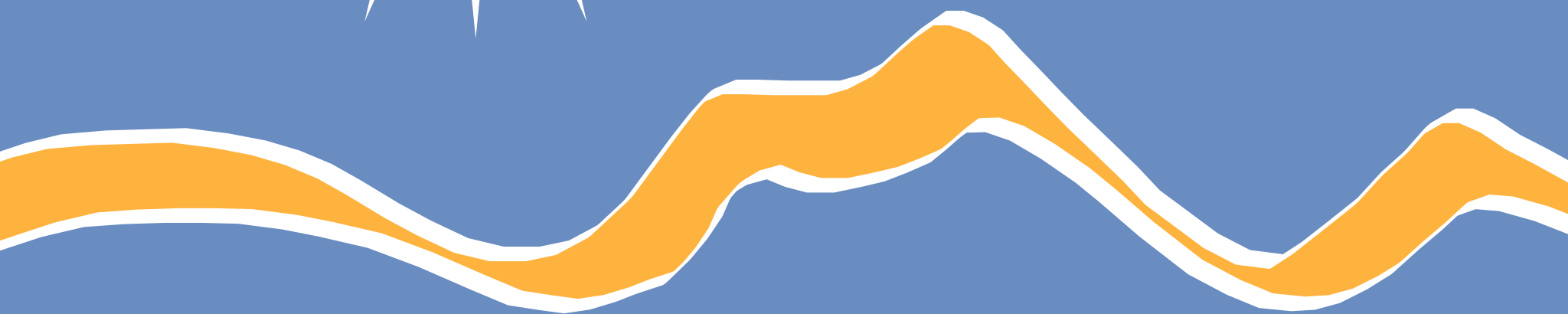
